Sealed bids can be hand delivered to the Charles Town Utility Board, Monday through Friday between the hours of 9:00 a.m. and 4:00 p.m. **A mandatory pre-bid conference will be held at the Charles Town Utility Board Office at 11:00 a.m., Wednesday, September 11, 2015. Representatives of the Owner and Engineer will be present to discuss the project. Attendance is mandatory. Bidders are required to attend and participate in the conference.**

Bids are for furnishing all labor, materials, equipment, and performance of work for the Charles Town Utility Board's Water System SCADA which includes the installation of SCADA equipment at the water treatment plant, raw water intake, seven (7) water storage tanks, and two (2) water booster stations and all other work necessary to complete the project as detailed in the contract documents prepared by Rummel, Klepper & Kahl, LLP.

Per the requirements of the Article 21-11-11 of the Code of the State of West Virginia, any Contractor submitting a Bid on this project hereby certifies, indicates, and acknowledges that he/she has a Contractor's license from the State of West Virginia and meets all the qualifications required by the statutes of the state and location in which the Work is to be performed.

Per the requirements of the Article 21-1D-5 of the Code of the State of West Virginia, any Contractor submitting a bid for a public improvement construction contract shall provide an affidavit of compliance that the Contractor has a written plan for a drug-free workplace policy. Failure to complete the Drug Free Workplace Conformance Affidavit Bid Form shall result in disqualification of the Bid.
