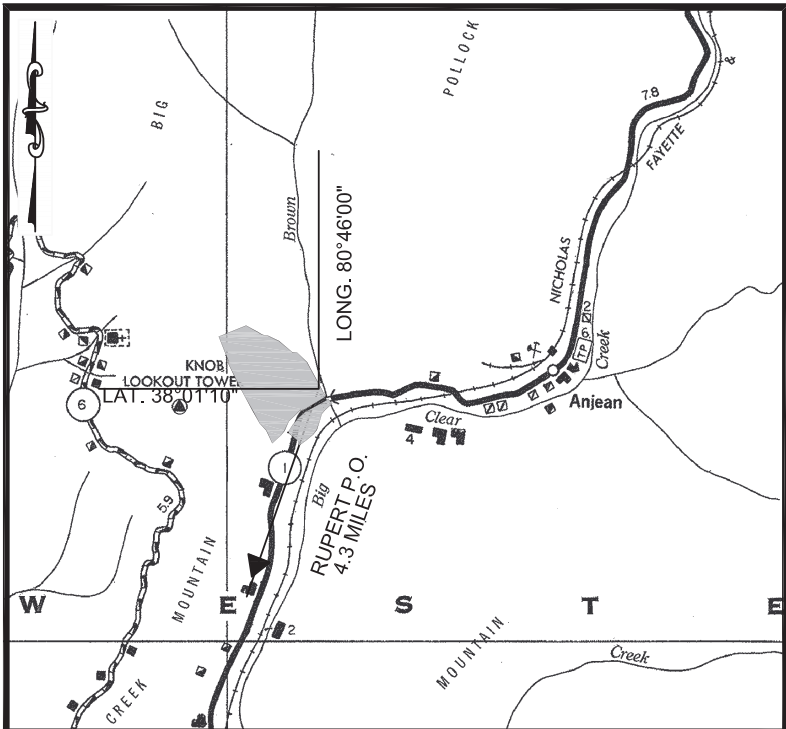




LOCATION MAP
