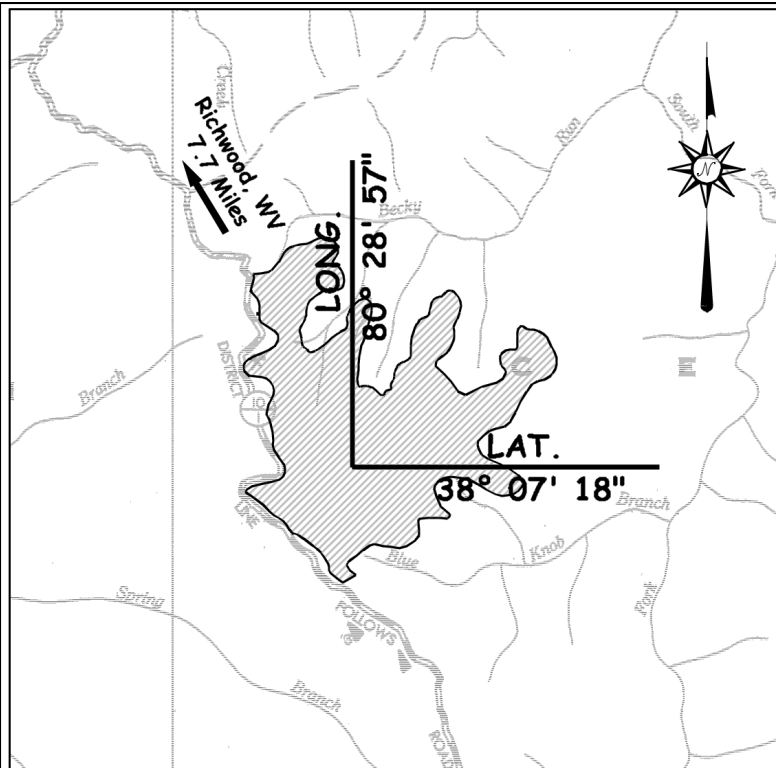




LOCATION MAP
