On February 28, 2019, Pendleton County Public Service District, a public utility, filed an application with the Public Service Commission of West Virginia, requesting increased rates and charges for furnishing water service to 762 customers at Franklin, Pendleton County.

The Staff of the Public Service Commission reviewed the application and recommends increased water rates and charges of \$29,871.00, annually, in additional revenue, an increase of 6.87% over current rates and charges. The present and the Staff-recommended water rates are as follows:

To help the Commission determine the justification for additional review and investigation, protests must be specific as to reasons that the changed rates and charges should not be modified. In addition, anyone desiring a hearing in this matter must request a hearing in the letter of protest. Hearing will be held, if the commission receives substantial protest, but is not automatically held.

If no hearing is requested or if there is no substantial protest, the Commission may affirm the Staff-recommended rates without a hearing.
