This is the amount by which capital outlay exceeded depreciation during the current year 1,019,312

Compensated absences due in more than one year is a long-term liability and therefore not reported in the fund level statements. This is the change in long-term compensated absences in the current year 27,518

Long-term pension liability is not due and payable in the current period and therefore is not reported in the fund statements. This is the change in long-term pension liability in the current year (844,042)

Some assets do not provide current financial resources and are not reported as assets in the fund level statements.

This is the change in deferred pension plan outflows 362,412

Some liabilities are not due and payable in the current period and therefore, are not reported in the fund level statements.

This is the change in the deferred pension plan inflows 442,189
